Adoption Program with Poland

In 1998, Catholic Charities began to investigate the possibility of serving as a child placing agency for Poland, and signed a formal agreement with Poland in January 1999. Catholic Charities of the Archdiocese of Chicago is pleased to continue this collaboration to help find loving, permanent families for children qualified or identified for international placement. We have a staff person in Poland who serves as our liaison and works with the entities in Poland to secure child referrals for our families, as well as presenting required documentation, and working with the families once they travel and are in-country.

WHO MAY ADOPT?

The following eligibility guidelines are specified by child placing authorities in Poland and Convention requirements:

- Prospective adoptive parents can be no more than 40 years older than the child they are adopting
- Married couples must be married at least 3, preferably 5 years.
- Single women may adopt
- Prospective adoptive parents must demonstrate the means to support the physical and educational needs of the child.

- At least one parent must be a U.S. citizen.
- Must be in good health
- Must have explored their medical situation regarding infertility, if applicable, and are not involved in infertility treatment.
- Must have a willingness to recognize and support the importance of a child's heritage and family of origin.
- Must be financially stable, with the ability to make two trips to Poland and stay for a period of up to 8 weeks during second trip.

WHO ARE THE CHILDREN AVAILABLE FOR ADOPTION?

In Poland, children become available for international adoption following the death of their parents, or extreme economic hardship or other crises that may cause parents to abandon their children or prevent them from properly caring for them. Their parental rights have been legally terminated, and the children are cared for in relatively small group homes, foster homes or orphanages. The children qualified for international adoption are typically:

1. Children between the ages of 6-15 years.
2. Children 5 years or younger with an identified medical condition.
3. Sibling groups, (may include a child under 6 years of age).

REFERRAL AND TRAVEL

Once your dossier has been completed and you have been pre-approved, your documents are sent to Poland for certified translation. The average wait for referral is 9 to 14 months. When a possible match has been made, a referral packet will be forwarded for you to review. The referral will include information on the medical, developmental and social history of the child or children. Following your acceptance of the referral, you will file for provisional approval of the children's visas, and then will be granted approval from the Central Authority, before you make your first trip to Poland to meet the child or children, and begin the legal processing of your adoption. This trip requires a stay of five business days.

The second trip is on average six weeks to eight weeks in length and for this trip both parents are required to travel to Poland prior to, and remain for both assigned court dates. It is possible for one of the parents to return to the U.S. after the second court date if necessary. During this time, you will await the final adoption decree and amended birth certificate, obtain your child's Polish Passport and other required documents before having a Visa Interview Appointment at the U.S. Embassy, which issues visas for all adopted children. *(More specific information on Visa requirements will be provided to you during your adoptive home study and preparation process.)*

Airfare, and accommodations vary considerably with travel season, number of required trips, orphanage location, family size, lodging preferences and length of stay. More detailed information will be available closer to time of travel. Adoption Fees and third party expenses are subject to change.

Any unforeseen additional fees or expenses in excess of \$1,000, incurred in Poland, for which the agency will hold the prospective adoptive parents responsible, will be disclosed to the adoptive parents, in writing, and their consent will be obtained, before the fees or expenses are incurred. The prospective adoptive parents have the option to waive the notice or consent requirement in advance.

Refund Policy - All fees are to be paid at predetermined intervals. Fees are non-refundable once the service has been provided. The Post Adoption Services Fee will be refunded in full, within 60 days, if the client does not complete an adoption. Catholic Charities reserves the right to terminate the adoption process of clients who fail to disclose information fully or properly or in any way place the agency at risk.
